Concerns about staff ratios on CHSLD units

Over the last few weeks, we have been contacted by many family members concerned about reduced staff on our units. Please rest assured: <u>no positions have been cut</u>. In fact, we have cut staff that were hired <u>as surplus staff</u> during the worst months of the COVID-19 pandemic.

The government had authorized us to hire additional staff to handle the many needs during the pandemic, but only on a temporary basis. We were instructed to return to our usual ratios and the deadline for that was July 1, 2021. Certain bonuses offered by the government were even terminated on that date.

Consequently, we have returned to our pre-pandemic ratios, which are the ratios authorized in our contracts with the CISSS. However, there is no question that after 18 months we will need an adjustment period to enable staff to resume their usual routines. It is possible that certain tasks may take longer, that wait times may be longer or that schedules may be disrupted, but this will all resolve in a few weeks.
